INTRODUCTION, LITERATURE REVIEW AND DISCUSSION

In today's rapidly changing complex globalization period, the development of information and communication technologies and the speed of information flow have a direct impact on family life, which, in turn, requires a person to be flexible in relationships in modern living and working conditions, and is a factor in the formation of imaginations and views typical of the times.

Concepts of "prosperous life" that began in the 50s and 60s of the 20th century have had a profound impact on people's imaginations and worldviews in terms of creating the basis of family life. Especially in the 80s and 90s of the 20th century, the main problems related to the stability of the family in society: a sharp increase in family breakdowns, a decrease in the number of births, an increase in the number of unmarried families, an increase in mental and nervous diseases and so on. the increasing number of such problems calls for a systematic study of the problems to be solved in this field. Such changes occurring in the life of the society are reflected in the minds of people and lead to the formation of unique concepts and ideas. For example, once divorce was understood as a special "isnad", but today it has become a factor that creates a sense of satisfaction in order to build one's way of life as desired. Moreover, with the provision of women's economic independence, marriage is no longer considered the result of the necessity of economic partnership, as it once was.

Studies show that there is a sharp difference between the perception of teenagers and the perception of married people about the important aspects that ensure a "happy family" and a "prosperous life". This situation is especially evident in the imagination of the spiritual and material life of the family. Life after marriage encourages the couple to build their own happy family with the help of their lifestyle and experiences and they begin to understand this social reality realistically.

Russian scientist S.V. Kovalev stated that young people are not satisfied with family-marital relations when they get married because they do not have enough correct ideas about family life and lifestyle. Therefore, in the places where young people grow up and study, preparing them for family life and marriage, forming the necessary qualities and qualities in them that ensure a happy family and a prosperous life, and saving them from romantic, sweet dreams about the future family, and all kinds of distractions, it is important to create valuable educational conditions. makes suggestions.

According to the results of research conducted in foreign countries in this field, in order for high school students to build a happy family, they must have two important aspects formed (possessed). The first is ideological maturity (also in relation to economic security), and the second is the formation of a culture of interaction and communication. In addition, young people who are building a family should be self-aware and try to reduce their own flaws, look at events and events from the eyes of others, be highly civilized in dealings, consider the wishes and views of others, It was found in the research that qualities such as glorification of love, stable trust in each other, high understanding of each other, respect and loyalty to each other should be embodied.

Leading sociologists and psychologists who have dealt with the issues of a happy family have determined that there are 11 of its most important conditions:

1. Mutual understanding of the couple. 2. Availability of separate housing. 3. Good financial support. 4. Children. 5. Belief in the continuity of marriage. 6. Having fun spending free time in the family. 7. Getting a job you like. 8. Relevance of information. 9. Comfort of the workplace. 10. Having good friends. 11. Freedom of husband and wife.

According to their research analysis, any family that has such opportunities can be called a happy family, and its members are living a happy and prosperous life. It also became clear that the conditions listed above for a happy and prosperous marriage in the family are not the same for the husband and the wife. For example, according to the importance of "mutual understanding between spouses", "availability of a separate house", "good financial security", "children" and "interesting work", the husband and wife were evaluated differently. The husband puts "separate housing" and "material well-being" first and second, followed by others, while the wife puts first and second "mutual understanding of the couple", "children" and then "separate housing", "material well-being" and "interesting work". It is clear from this that the most important part of the content of a happy and prosperous family is the necessary conditions of life and activity, the important content of the stability of the children's family union.

In the field of studying family relations, Estonian scientists E. Tiyd and V. The research carried out by Ukolova is noteworthy. They develop its models depending on the nature of the couple's relationship in the family. According to them, in today's society there are more than 2 models of the family: the traditional (asymmetric) family model and the modern (symmetric) family model. In a traditional (asymmetrical) family, the husband is considered the economic provider of the family and its head. He determines the position of the union in the family. It determines the solution of organizational and other important problems of family life. Therefore, the husband is freed from other worries in the family. And the woman in traditional families does not bring much income or brings relatively little income. The most important thing for him is to have children (birth) and exemplary management of the household, to control children and deal with their development. Accordingly, since the responsibility of running a family largely depends on him, the concern of creating and shaping the micro-environment in it is mainly his duty. In a modern (symmetrical) family, the relationship between husband and wife differs from that in a traditional family (or this family is also called an egalitarian (French - equality) family), all roles in it, whether economic or educational, are carried out in cooperation and togetherness of the spouses. They run the family together, solve its issues and problems together, even up to educational issues. Also, according to E. Tiyd and V. Ukolova, the stability of the family is determined by the fact that the relations in it are directed towards specific goals. They distinguish the purpose of family relations to be more in 3 directions. Family relationships are stable when:

- 1. The purpose if it is connected with the upbringing of children;
- 2. The goal is to justify the further development of the couple as individuals;

3. If the goal is to provide the necessary things for the family, the home is cozy and comfortable.

It can be seen that family stability is the result of very complex, multi-faceted and multi-level relationships of family members based on mutual respect, love, responsibility, and psychological and According to the results of most studies, the most important reasons for family breakdown are: loss of trust between spouses, weakening of character (love), incompatibility of character traits, inability of one of the spouses to bear children, or sexual dissatisfaction. We can clearly see such results in the research conducted by psychologists from far and near abroad. The formation of the culture of interpersonal relations in the family creates an opportunity for family members to realize their desires and abilities to find their place and value in society sexual compatibility of the couple.

Therefore, it is necessary to explain to today's youth the important causes of family breakdown, as well as prove the influence of very complex factors that lead to family instability. If experiences about family relationships are not formed enough or are not formed, then various problems and conflicts are formed. Harmony is lost in the family and an unpleasant psychological atmosphere is created in it. Family members cannot find their place in society either. The most important thing is that such a situation has a negative impact on the development of children.

CONCLUSION

In solving the above-mentioned problems, it is necessary to focus the attention of the general public on the following issues in order to ensure that the imagination of young people about family life is in harmony with real life:

- Not forgetting the role of family interaction in the formation of social competence or the culture of interaction, which is recognized as the level of satisfaction with family life, parents who are connected to social networks (telegram) without turning away from various series, in the words of psychologists, by establishing a 10-minute dialogue with their children, develop the personality of the child it should not be overlooked that it fulfills the task of socialization, which in turn is the basis for social knowledge and the transfer of social experience. Because in S. L. Rubinstein's opinion: "The basis and core of human life is the attitude towards other people and people. A person's "heart" is woven from his relationships with other people; its evaluation is determined depending on what kind of human relations a person strives for, and how he can establish a relationship with people and other people. Analyzing human life on the basis of a person's relationship to other people is the core of psychology."
- ➤ It is necessary to carry out practical studies on the development of criteria that determine the spiritual and moral maturity of a person, which determines the maturity of young people for family life and marriage, and it is necessary to draw the attention of the general public, especially scientists, scientific researchers. Because a specific criterion and description about this aspect has not been developed yet. It is also necessary to take into account the issues of psychological maturity.
- ➤ Today, young people who migrate abroad in order to achieve a "prosperous life" and earn good money bring with them various sexually transmitted diseases, which in turn limits the possibility of having children, which is the main factor of satisfaction with family life. we must not forget that satisfaction is not fulfilled only by ensuring material abundance. This, in turn, puts on the agenda that we should once again analyze the issues of harmony of material values and spiritual qualities.
