It is interpreted that charity should be a natural duty of man. Because he should donate his blessings to others: "You should donate (to God's servants) as Allah has donated to you," says the 77th verse of Surah Qasas. It is also emphasized that whoever donates to someone, the benefits will return to him, because the person who does good to someone will feel spiritual satisfaction and will be respected by others. This good feeling in people is mentioned in verse 160 of Surah "Anom" "Whoever does a good deed, it will be returned to him tenfold."Whoever commits a bad deed will only be punished in proportion to it."

In the Holy Qur'an, parents are first included among the people who deserve charity and the rights of parents are determined. In verses 23-24 of Surah Al-Isra, kindness to parents is emphasized as the second duty after praying to Allah.

No matter who the parents are, the child should respect them and not take their word back; it is emphasized that the parents, along with giving birth to the child, also gave the child education, always be ready for their rights.

In these verses, the following are defined as the highest rules of human behavior:

- > parents' behavior does not suit the child,
- ➤ when talking to parents, do not say words that hurt them,
- $\succ$  to pay respect to parents,
- $\succ$  mercy to parents,
- $\succ$  to pray for them.

In the "Holy Qur'an" it is emphasized to do good not only to parents, but also to other members of the family: relatives, orphans, the poor, relatives.

In verse 36 of Surah Nisa, "Do good to your parents and relatives, the orphans and the poor, the relative and the stranger, your companion and the hired stranger!" encourages people to do good to each other.

This verse has great moral and social significance. Because the strength of each family leads to the strengthening of the society, and the care of each orphan leads to the maturation of a morally high person who works for the fate of the society. Neighborly harmony helps to strengthen the neighborhood, which, in turn, leads to the stability of the community. Therefore, the above surah also expresses the strong connection between family and society. It is known that Islamic beliefs, beliefs and requirements, legal and moral norms are expressed in the "Holy Qur'an" and its commentaries, "Hadith Sharif" and Sharia manuals and theological literature.

"Holy Qur'an" is a great wealth of world culture, the holy book of all Muslims, and means "Recitation" in Arabic. "Holy Qur'an" consists of 114 chapters.
